As stated in the Limited Warranty of the User Agreement, I accept sole responsibility for the saving of my data.

#### Membership of the Family Hotel Club allows me:

- ✓ to have multiple licenses for the same establishment (for a network use of the software);
- ✓ to use the latest available version of Family Hotel, while recuperating all of my data saved from previous versions;
- ✓ to benefit from the telephone helpdesk, should I encounter an urgent problem with the software;
- ✓ to receive email support for any question not answered in the user documentation;
- ✓ to be able to download the members' reports, accessed via the report catalogues online (found on the menu, right-click "Import from the catalog...", on the Tool Bar of Family Hotel);
- ✓ to be eligible for members' benefits, as described in the price list;
- ✓ to contribute to the future development of the software and to provide you with my suggestions for improvement of the software (without obligation on your part).

The fee quoted is an **annual** fee. The renewable yearly date of my membership starts on **the day and month of my first activation of Family Hotel license**. Membership is renewed automatically every year. Membership is without commitment of duration and can be suspended without notice at any given moment by myself (the user) or by yourself (the software publisher). In this latter case, I accept to lose – immediately - all Family Hotel Club member rights (specifically the help provided for urgent problems with the software and the right to possess more than one license)
